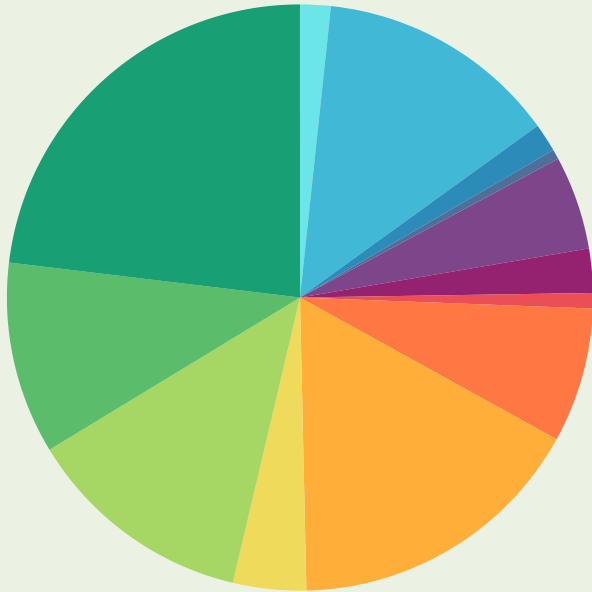

TAX RATE BROKEN DOWN

The Archer Lodge Tax rate is \$0.30 per \$100 valuation. Out of the \$0.30, it is broken down as follows:

- \$0.115 goes to Fire
- \$0.02 goes to the Park
- \$0.165 goes towards the operation of the Town
