RESOLUTION ENDORSING THE SOUTHEAST AREA STUDY BY THE TOWN OF ARCHER LODGE

WHEREAS, the Town of Archer Lodge is an active member of the Capital Area Metropolitan Planning Organization (CAMPO) with representation on the Executive Board and Technical Coordinating Committee; and

WHEREAS, CAMPO is completing the Southeast Area Study, building on the work completed through the Southwest Area Study and Northeast Area Study, a regional comprehensive transportation planning initiative covering portions of Wake and Johnston Counties, and eleven municipalities, including the Town of Archer Lodge; and

WHEREAS, the Southeast Area Study will inform CAMPO's next Metropolitan Transportation Plan update; and

WHEREAS, the Southeast Area Study includes Hot Spot studies of the towns of Archer Lodge, Garner, and Smithfield targeting specific transportation issues in each community and offering recommendations and resources local decision-makers may use to better transportation and community goals; and

WHEREAS, during preparation of the Southeast Area Study that members of the Archer Lodge Town Council, the Planning Board, community residents, and the planning staff participated in public forums and provided feedback about local and regional transportation needs to CAMPO and its consulting team; and

WHEREAS, the Archer Lodge Planning Board at its meeting held March 15, 2017 unanimously passed a motion advising the Archer Lodge Town Council of its endorsement of the Southeast Area Study; and

NOW, THEREFORE, BE IT RESOLVED by the Archer Lodge Town Council that it endorses the Southeast Area Study to the Executive Board of CAMPO and this Resolution expresses the appreciation of the Mayor and Town Council for the additional Hot Spot study and the recommendations and resources it provides to the Town of Archer Lodge.
